We received offers of help from the floor to join most of the proposed groups and they will be contacted soon after the meeting. More volunteers will hopefully be recruited.

- It was agreed we continue to collect for Air Ambulance and continue to advertise payments which can be made via bank transfer if members prefer to pay this way.
- Bob shared the story of Ray Hudson, a strong member of the club in 70s/80/s who had a serious accident on a ride. There is a memorial bench to him at Yarningale Common, one of his favourite spots. The CTC Plaque fixed to the bench was stolen and there is a wish for it to be replaced. The meeting agreed to expenditure £50-£100 for replacement. Committee to progress this.
