Compliance with the Data Protection Act (2018)

General Principles

Personal data is any information about an individual. Obviously some information (e.g. Sexuality, religious/political beliefs and mental/physical health) is more sensitive than others. But even rather mundane information such as

- Name
- Mobile phone number
- email/postal address
- Photograph

must only be used for the specific purpose it was intended for and only shared on a 'need to know' basis.

Current practice

- 1. The only personal data collected and held on an indefinite basis is:
 - Name
 - Gender
 - Mobile phone number
 - Email address
 - Participation on CTC Coventry rides. Tours and events will be included from March 2023.
 - Which, if any, rides/tours/events led.
- 2. Other personal data. This is only collected for people who attend an event. It is deleted within 30 days of the end of the event:
 - In Case of Emergency information
 - Parental consent forms
- 3. The collection and holding of any other data about an individual needs to be discussed by the committee to determine
 - a. Evidence of consent by the individual.
 - b. Need to hold such data.
 - c. Means of securing the data.
 - d. When the data should be deleted and how to ensure deletion occurs

Outstanding issues

A deletion date and process needs to be established about the data in (1) above regarding people who haven't attended for some time.
